

## **CONDITIONS AND AGREEMENTS (Please read carefully)**

1. A formal acceptance and clothing list will be mailed upon receipt of registration.
2. **SUMMER CAMP REGISTRATION:** Registration application must include a \$400. per week deposit with the balance due by June 1st . Please include postdated cheque for the balance if paying by cheque and not paid in full. If payment is paid by credit card, please complete bottom right of this page. All balances must be paid by June 1st . The administration has the right to cancel any session if the balance owing is not paid by June 1st . Remember to include 5% GST on the amount.
3. **REFUND POLICY:** Registrations may be cancelled on or before April 15th for full refund minus a 10% administration fee. For refunds after this date, we suggest you purchase cancellation insurance through a travel agent. Call us for a contact name and number. There are no refunds for personal injury. Insurance coverage for personal injury of the student is the responsibility of the undersigned. No refunds will apply for students sent home for misconduct. The camp director reserves the right to dismiss any camper who in her opinion is a hazard to the safety and rights of others or who has rejected the rules of the camp or is not compatible with camp program. No discount of fees will be offered for any reason for registrants arriving late or leaving early during the period for which they are registered. **ARRIVAL TIME IS SUNDAY BETWEEN 3:00 AND 5:00 P.M.** No early arrivals without prior arrangements. **DEPARTURE TIME IS FRIDAY AFTER THE SHOW. APPROXIMATELY 4:30 PM.** Additional fees will be charged for early arrivals and late departures.
4. **Weekend camps and 5 day adult camps:** Registration application must include a deposit of 50% per session with the balance due upon arrival. The registration may be cancelled on or before one month prior to arrival date for a full refund of fees, minus 10% administrative fee. For refunds after this date we recommend you purchase cancellation insurance through a travel agent. You can call us for a contact name and number for this insurance. **ARRIVAL TIME IS BETWEEN 5:00 P.M. AND 7:00 P.M. WITH DEPARTURE TIME OF 5:00 P.M.**
5. We are uninsured and unequipped to teach students that are physically, emotionally or mentally challenged, and regret that we are unable to accept registrations for such students. Some weight restrictions may apply for less experienced riders.
6. Insurance coverage for personal injury of the students is the responsibility of the undersigned.
7. A \$15.00 minimum handling and shipping charge will apply for any articles left behind that require mailing.
8. **TRANSPORTATION:** Pickup and Delivery: Kelowna Airport \$45.00 – Vernon Bus Depot - \$25.00 Waiting time \$6.00 per 15 minutes. These rates are priced per person, one way. (Prices may vary for groups, please inquire) Lower Mainland shuttle \$125.00 from North Vancouver and Abbotsford to camp. (4 person minimum) Please include the 5% GST. These rates are subject to change depending on fuel costs.
9. Any deviation from the foregoing will be made at the discretion of the Director of Aspengrove Equestrian Academy.
10. **AGREEMENT FOR RELEASE AND WAIVER OF LIABILITY.** I fully understand that horseback riding , handling and grooming of horses and other stable activities are very dangerous. All animals may be unpredictable, and while Aspengrove exercises care in the selection, training and use of its horses, it is impossible to guarantee the behavior or actions of the horse at all times, or in all situations. I wish to participate or allow my child to participate in these activities knowing that they are dangerous. I accept and assume all the risks of injury (including death) to my child or myself or my property. I represent and warrant that I have the authority to give this release. In exchange for my child or myself being permitted to participate in these activities for my child, myself, my child's heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against Aspengrove Equestrian Academy or its owners, directors, or

employees from any injury (including death), to my child or myself, or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my child's or my participation in these dangerous horseback riding or related activities or all other camp activities; and I also agree that if anyone makes any claims because of any injury to my child or myself (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims.

11. The undersigned hereby certifies that they are the legal parent or guardian of the child and that they desire the child to participate in the full program all activities, unless they provide other advice in writing. Further, that if the registrant should become ill or suffer an accident requiring medical attention, the Directors of Aspengrove are granted full permission to take whatever action they may deem necessary or advisable, and to authorize appropriate medical treatment, recognizing that every reasonable effort will be made to contact the parent or guardian. The undersigned agrees to be responsible for any expenses incurred.
12. The parent or guardian (if registrant is under 19) or registrant must sign this form in order to be registered.
13. I understand that photographs of myself or my child from the camp may be used for advertising or promotion and that my positive statements about Aspengrove may be used as testimonials for publicizing the camp.
